



## ISSCR Abstract Submission Agreement

Submission of an abstract to the ISSCR constitutes the submitting authors' acknowledgment and agreement to the following terms and conditions. Failure to comply with these terms may result in abstract rejection.

### A. **Submission Standards**

Abstracts must contain substantive experimental, calculated, or theoretical results. Clinical case studies will not be considered. Abstracts of commercial products must include experimentally derived, quantitative data. The ISSCR may request additional information from authors to ensure that the work reported in an abstract complies with these standards.

While abstracts are evaluated for scientific interest and are citable, the brevity precludes rigorous peer review. Thus, acceptance of an abstract by the ISSCR should not be interpreted as endorsement of validity or safety of the research by the ISSCR.

### B. **ISSCR Research Conduct Policy**

Submission of an abstract constitutes a formal agreement by the authors that the reported research has been conducted in accordance with relevant institutional and national guidelines, regulations regarding experiments on human subjects, live vertebrates or higher invertebrates, and the [ISSCR Guidelines for Stem Cell Research and Clinical Translation](#).

### C. **ISSCR Research Communication Policy**

The ISSCR is committed to ensuring that the public presentation of stem cell research and its applications is conducted responsibly to avoid misrepresentation or misleading the public (see Recommendation 4.1, [ISSCR Guidelines for Stem Cell Research and Clinical Trials](#)). This is especially important for sensitive areas of research including chimeras, embryo models, and some brain organoid studies. For example, [the ISSCR advises against](#) using the term "synthetic embryo" to describe stem cell-based embryo models.

### D. **Not Published Elsewhere**

Abstracts must be based on results that have not been published in their entirety or have been published within the last 6 months.

### E. **Identical Policy**

Presentation material at the meeting must be substantively identical to that described in the abstract. In particular, the title, authorship, and scientific content of the presentation must match the abstract. Authors unable to



present in person must notify the ISSCR immediately by email. The ISSCR will make the final determination regarding substitutions.

**F. Presentation Limits**

An individual may appear as the presenting author on only one accepted oral abstract. No presentation may be given by an individual who is not an author on the abstract. An individual may present a maximum of one oral and three poster presentations during the meeting.

**G. Author Consent**

Authors may not be listed on an abstract unless they have provided consent to the submitting author. All material must be the work of the authors listed.

**H. Full Disclosure of Information**

Transparency is vital for the open sharing of information. The ISSCR requires full disclosure of conflict of interests, the identities of genes, proteins, chemicals, active agents, etc., in all presentations, both oral and poster.

**I. Presentation Agreement Remuneration**

Abstract submission implies an understanding that the authors will receive no remuneration from the ISSCR for their participation, except as explicitly specified in writing by the ISSCR.

**J. Permission for Use of Name and Likeness**

Authors give the ISSCR, its agents, and representatives the right to use their names and likeness in promotional and other materials related to the meeting.

**K. Permission for Publication, Recording and Use of Material**

Authors grant the ISSCR a one-time, worldwide copyright to publish the submitted materials and associated oral or poster presentations (including video, audio, and slide recordings) in the conference proceedings, in any print or electronic medium, for distribution and sale to attendees, ISSCR members, and other parties in accordance with policies established by the ISSCR Board of Directors, with all rights afforded under U.S. and international copyright law. The ISSCR holds the copyright in the compilation of the proceedings, while authors retain copyright in the individual contribution, along with the right to reprint the submitted materials elsewhere. Authors are encouraged to include copyright notices and are solely responsible for registering any copyright. Authors warrant that the contribution is original, lawful, non-defamatory, non-infringing, and that any

third-party rights have been secured at authors' expense, with documentation provided to the ISSCR upon submission.

**L. Indemnification Agreement**

Authors agree to indemnify and hold harmless the ISSCR, its agents, and representatives should the material presented or provided for publication be determined to defame, libel or slander an individual or organization, violate the confidentiality of any individual or organization, or infringe on another's copyright.

Submitting authors must agree to the above terms at time of submission.
